**This Wavier Must Be Signed By All Persons Using Campbell River Trail Riders Facilities**

1. All riders and persons staying at the CRTR facility must sign a CRTR wavier. A photo copy of your Current HCBC membership must accompany the completed CRTR wavier.
2. All minors must be accompanied by parent/guardian or an instructor at all times. This rule also applies to #3 #4 #5 #6 #7
3. All members and non- members are permitted to camp. All camping must be Scheduled in advance.
4. Non- members wanting to ride must call for available opening to ride 1 week in advance.
5. All groups wanting to rent the **Campbell River Equestrian Centre** must book in advance
6. All clinics or lessons must be scheduled in advance (Instructors must have their own Instructors insurance and a copy must be given to facility administrator.)
7. All mounted riders must wear approved helmet on grounds.
